***Dispute of Ownership of County Dublin Estates Acquired Under Deed of Settlement 1620-1865***

Covering note from Lyons from Dublin explaining to Lord Palmerston that he is unable to travel to Sligo due to an unfortunate accident at Covent Garden in London, 23 May 1797; [BR137/45/8] Lower Sligo is in a state of confusion and Lyons has appealed to Thomas Pelham [Lord Lieutenant of Ireland] who has sent a company of the militia to Cliffony, 30 May 1797
