A1021 Deeds for the Irish estates and family settlements of the Earls of Mornington, 1681-1876

Wellesley Pole married on 17 May 1784 Katherine Elizabeth Forbes, the first daughter and coheir of Admiral the Hon John Forbes (second son of George, third Earl of Granard). Her sister Maria married J.C.Villiers, later third Earl of Clarendon. Wellesley Pole's daughter, Emily Harriet (1792-1881), married Lord Fitzroy Somerset, later first Baron Raglan (1788-1854); and his daughter Priscilla Anne (1793-1879) married John Fane, Lord Burghersh, later eleventh Earl of Westmorland (1784-1859). His son, William Wellesley Pole, later Pole Tylney Long Wellesley, fourth Earl of Mornington (1788-1857), married, firstly, Catherine Tylney Long (1789-1825) in 1812; and secondly, in 1828, Helena Bligh (d. 1869), the widow of Captain Thomas Bligh.

Deeds for the settled estate of Admiral Lord Forbes in Ireland, 1681 (letters patent under the Irish Great Seal, Feb 1681, in favour of Viscount Granard; mortgage deeds and deeds of assignment, 20 Aug 1720; 31 Oct 1724; 7 Feb 1727/8; 30 Aug 1728; 19 Mar 1734/5), with correspondence from 1813 relating to the use of the properties to secure the jointure and maintenance of Priscilla, daughter of William Wellesley Pole, on her marriage to John Fane, Lord Burghersh in 1811

Deeds: deed to provide collateral security for raising portions for the younger children of the marriage of William Wellesley Pole, later fourth Earl of Mornington (1788-1857) and Catherine Tylney Long (13 Mar 1812), charged on Irish estates listed in a schedule (conveyance from William Wellesley Pole, senior and junior, to Charles Bagot and the Duke of Beaufort as trustees); surrender of the term of years by Bagot and Beaufort to William Wellesley Pole, senior and junior, and Catherine the latter's wife, 5 Dec 1815; with related correspondence, 1812-30

*Properties*: lands in Queen's County — Camcloane, Cappanush, Irey, Clonurk, Ballyfin

Deeds: mortgage by William Wellesley Pole, senior and junior, to Arthur Wellesley, first Viscount Wellington, for £3250, of lands detailed in accompanying exemplifications of recoveries in the court of Common Pleas in Dublin, release to uses and deed for suffering recoveries, for lands in Queen's County, King's County, Co. Cavan and Co. Westmeath, Feb 1810

Deeds: deed of appointment and grant of a rent charge of £1500 p.a. from lands in Queen's County, King's County, Co. Westmeath and Co. Cavan, by William Wellesley Pole, third Earl of Mornington, to the trustees of his son, later the fourth Earl, Feb 1810; deed for securing the payment of an insurance on the life of William Wellesley Pole, later the fourth Earl, for the payment of an annuity of £600 to the third Earl should he survive his son, to be charged on estates [in Hampshire and Essex] in the event of failure to sustain the insurance, 22 Jul 1823; deed of agreement between William Wellesley Pole senior and junior, and Lord Fitzroy Somerset and Sir Charles Flint (trustees of the future fourth Earl),

for the raising of £1000 on lands in Hampshire and Essex, 23 Jul 1823

Deeds: leases and release, 25 and 26 Mar 1783, between Henry, first Earl Bathurst; Joseph Elderton; William, Duke of Queensberry; Thomas, Earl of Clarendon and Charlotte his wife; Admiral Hon. John Forbes, Catherine Elizabeth Forbes and Maria Eleanor Forbes; Francis Russel and John Lamb, for the use of the Countess of Clarendon

Mortgage of lands in Co. Westmeath by William Wellesley Pole, senior and junior, to Lord Wellesley for £7000, 14 Feb 1810; deed to lead the uses of a fine, between William Wellesley Pole, third Earl of Mornington, and his wife Catherine, and the future fourth Earl and Frederick Thompson, 24 Apr 1811, for releasing lands in Ireland from the jointure of Catherine under the deed of settlement of 15 June 1784

Deed, by demising the Irish lands granted in the patent of 1681, between William Wellesley Pole, third Earl of Mornington, Lord Burghersh and the trustees (Lord Wellesley, J.C.Villiers, Lord Lonsdale and Henry Fane) for securing the payment of annuity of £400 to WWP3 so long as Lord Burghersh and his wife Priscilla and the children of their marriage shall live, 23 Jul 1811

Deeds: settlement on the marriage of Garret Wesley, first Earl of Mornington, with Anne Hill, 6 Feb 1759

Settlement on the intended marriage of Lord Fitzroy Somerset with Emily Harriet Pole, second daughter of William Wellesley Pole, third Earl of Mornington, 2 Aug 1814 (trustees are Duke of Beaufort, Duke of Wellington and J.C.Villiers)

Deeds: special probate of the will of Admiral John Forbes (will 1795, probate 1796); probate of the will of William Wellesley Pole, third Earl of Mornington (d. 1845), for his property in England and Wales

Appointment between William Wellesley Pole senior and junior for lands in Co. Dublin, Meath and Wexford for securing portions for the younger children of the intended marriage between the future fourth Earl of Mornington and Miss Tilney Long, 13 Mar 1812

Deeds releasing, assigning and appointing lands and personal estate formerly of the Countess of Clarendon to William Wellesley Pole, third Earl of Mornington, Apr 1844; releases from the residuary legatees of William Wellesley Pole, third Earl of Mornington, 1852 and 1876

Deeds: probate of the will and codicils of Catherine Elizabeth, dowager Countess of Mornington, 29 Nov 1851; draft of transfer and transfer of securities for £2000 to Mr Burrell as trustee for Lord Mornington's executors, May 1852; securities for transfer of £3000 charged on estates in Co. Cavan vested in Mr Burrell as trustee for Lord Mornington's executors, 1848
